## Introduction

I hope you all enjoyed the summer and managed to fit in a little bit of battlefield history. I holidayed in the Dordogne and visited Castillon, the last battle of the Hundred Years War. Although the battlefield is not particularly accessible there is a monument to Sir John Talbot who was killed there with some basic interpretation. My 2016 battlefield highlight though was a July trip to Germany incorporating a visit to Lutzen, a Thirty Years War battle where the Swedish King, Gustav Adolf, was killed. But you don't need to go so far to visit a battlefield and the Mercia region, with support from its partner organisations, has offered several opportunities this year. The Mercia committee is about to start planning next year's events, so please let me know what you would like to see on the 2017 schedule.

## Recent Events

Back in May, Harvey Watson led a small but committed group across the 1469 battlefield at **Edgcote**, exploring the different interpretations of this less well-known battle. In June, Mike Ingram ran a tour of **Naseby** battlefield as a fundraiser for the Northampton Battlefields Society and the next month the Society put on another excellent battlefield anniversary event for **Northampton** (1460) at Delpare Abbey. Here the Society and its Chair, Mike Ingram, were deservedly awarded the Battlefields Trust President's prizes for outstanding work on battlefield preservation and interpretation. At **Chalgrove** (1643) in August, I led a well attended walk across the battlefield where the parliamentarian statesman, John Hampden, was mortally wounded. In a joint walk with the John Hampden Society, I explained the different interpretations of the battle and concluded with details on the threat to the battlefield (see below). Finally at the end of August Adam Dolling led another successful War of the Roses walk at **Nibley Green** (1470). A number of local people attended the and provided information on military related finds

and some local traditions about the battle which Adam is planning to follow-up

## Chalgrove (1643)

As trailed above, Chalgrove battlefield is under threat from development. South Oxfordshire District Council has recently completed public consultation on its 2032 Local Plan which proposes the building of 3,500 houses on Chalgrove Airfield, a WWII photo-reconnaissance base, which covers around one third of the Historic England registered battlefield. The Trust, the John Hampden Society and Historic England have all objected to the development and the Council acknowledge that further work needs to be done on the proposals to prevent damage to the battlefield. Nevertheless the Battlefields Trust is set to continue its opposition in the event the public consultation does not bring about changes in the plans. It is in touch with local people opposed to the development and intends to work with them to prevent the destruction of this important site.

## Tewkesbury (1471)

In the last edition of the newsletter I reported that the Tewkesbury Battlefield Society had been told it could not buy land on the battlefield at The Gastons following a decision by the Tewkesbury School Trust Fund that owns the land. In July this year the Battlefield Society launched a petition as

### **Historic England Registration Review**

Historic England has, over the last few years, been reviewing many of the 46 English battlefield registrations with help from the Battlefields Trust. In Mercia Region Shrewsbury (1403) and Worcester (1651) have been completed. Shrewsbury saw the addition of a small strip of land to align the registration with the A5124 road, which had not been constructed when the battlefield was originally designated. Disappointingly, at Worcester Historic England declined to register the Middle Battenhall Farm area that was recently under threat, but remains open to new evidence to change the decision. The Tewkesbury review is about to go to public consultation and a link to this will shortly be made on the Battlefield Trust's website.

### **John Hampden's Battlefields**

The Mercia Region has organised a Winter series of talks with the John Hampden Society looking at the battles where John Hampden fought. These will be held in the Bucks County Museum in Aylesbury at 2:30pm on Saturday afternoons between November 2016 and February 2017. Professor Ian Beckett will give first talk on the Civil War in Buckinghamshire on 12 November, no doubt drawing on his recent book, *Wanton Troopers*, on the Civil War in the county. The remaining talks are on 3 December (Southam and Edgehill), 21 January (Brentford and Turnham Green) and 25 February (Reading and Chalgrove).
